## WEconnect Health Management Mobile Application

This is an advisory notification to Molina Healthcare of California (MHC) network providers applicable to the Medi-Cal line of business.

## What you need to know:

#### What is WEconnect?

WEconnect is a mobile application (phone app) built by people in recovery for people in recovery with the goal of saving lives and improving outcomes. WEconnect helps people change behavioral patterns toward improved health by addressing mental, behavioral and substance use related challenges. WEconnect applies contingency management (rewards in the form of digital gift cards), customized peer coaching, and a variety of virtual support meetings offered multiple times a day to help members establish and stay on their positive change journey.

If you are working with a Molina Primary Medi-Cal patient to make a **behavioral change** related to mental health or substance use, consider referring to WEconnect. You could then ask your patient to show their progress at their next scheduled appointment and even ask them to make attending your next appointment a rewardable event! If you make the referral using the live link, they can download the app right away and get started.

Primary Molina Medi-Cal members are eligible for Molina funded WEconnect access, but they require a referral from a health provider to access the full array of support. A health provider can be anyone on that patient's care team. (For example: PCP, Peer specialist, Case Manager, NP, Counselor, Therapist, ECM, CHW, etc.)

There is absolutely no cost to the patient or the referring organization.
