## Transition to Availity for Skilled Nursing Facility Workforce and Quality Incentive Program (SNF WQIP) Bed-Days Reporting

This is an advisory notification to Molina Healthcare of California (MHC) network providers applicable to the Medi-Cal line of business.

#### What you need to know:

#### Background of the SNF WQIP

The California Department of Health Care Services (DHCS) has implemented the Skilled Nursing Facility Workforce and Quality Incentive Program (SNF WQIP) to provide performance-based directed payments to eligible SNFs. This program aims to incentivize workforce and quality improvements in SNFs for Rating Periods between January 1, 2023, and December 31, 2026.

We are pleased to inform you of a significant enhancement in the way we distribute SNF WQIP bed-days reports. Effective April 2025, Molina Healthcare Plan of California, Inc will transition from email-based reporting to the Availity platform. This change is aimed at improving the accessibility, and efficiency of our reporting process.

Starting April 2025, all SNF WQIP bed-days reports will be exclusively available through Availity.


