Prior Authorization Code Removal

This is an advisory notification to Molina Healthcare of California (MHC) network providers applicable to all lines of business.

What you need to know:

Molina's Prior Authorization Modernization evaluated the clinical benefit and value of all codes for which Molina has historically required prior authorization. A comprehensive review has resulted in a large number of codes being removed from the prior authorization list starting in Q4 2023.

Molina's ultimate goal is to ensure that our members get the right care at the right place and at the right time. Additionally, we anticipate that this update will decrease administrative burdens while still ensuring the delivery of high-quality health care.

As a reminder, it's crucial to stay informed about any changes or new information that might impact your practice. Please remember to check the Prior Authorization (PA) matrix periodically to ensure you are up to date with the latest changes.
