Informational Bulletin Regarding Emergency Declaration – Strengthen Robust State Response to Bird Flu

This is an advisory notification to Molina Healthcare of California (MHC) network providers applicable to all lines of business.

What you need to know:

Governor Gavin Newsom declared a statewide emergency on December 18, 2024, to streamline and accelerate California's response to Avian Influenza A (H5N1), commonly known as "Bird Flu." This decision follows the detection of cases in dairy cows on farms in Southern California, underscoring the need to expand monitoring and enhance the coordinated statewide effort to contain and mitigate the virus.

To date, no person-to-person transmission of Bird Flu has been detected in California, and nearly all infected individuals had direct exposure to infected cattle. The state has already implemented the nation's most extensive testing and monitoring system to address the outbreak. This emergency proclamation will grant state and local agencies additional flexibility with staffing, contracting, and other regulations to adapt to the evolving response needs.
