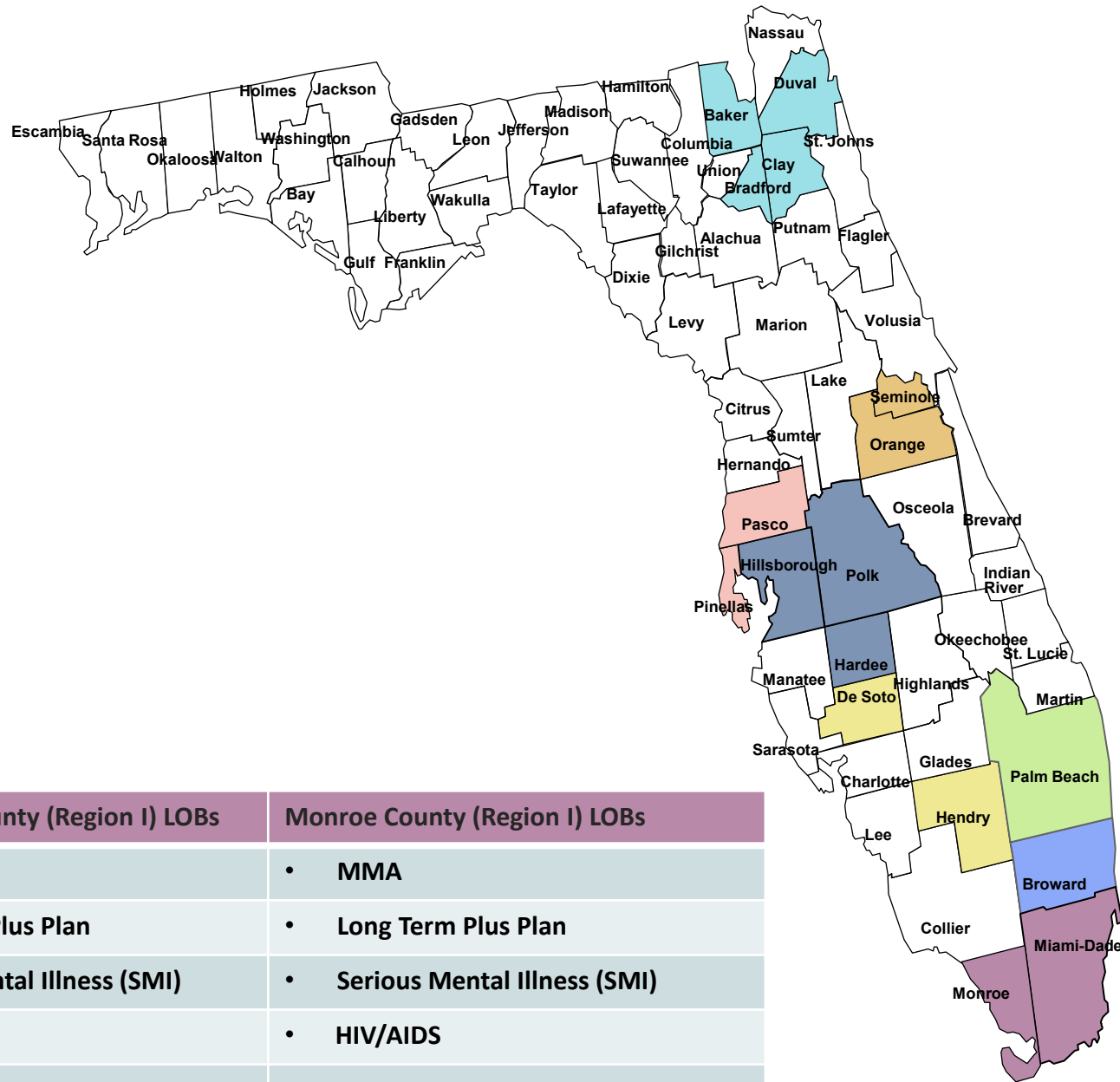


Health Plan Territory Map 2025

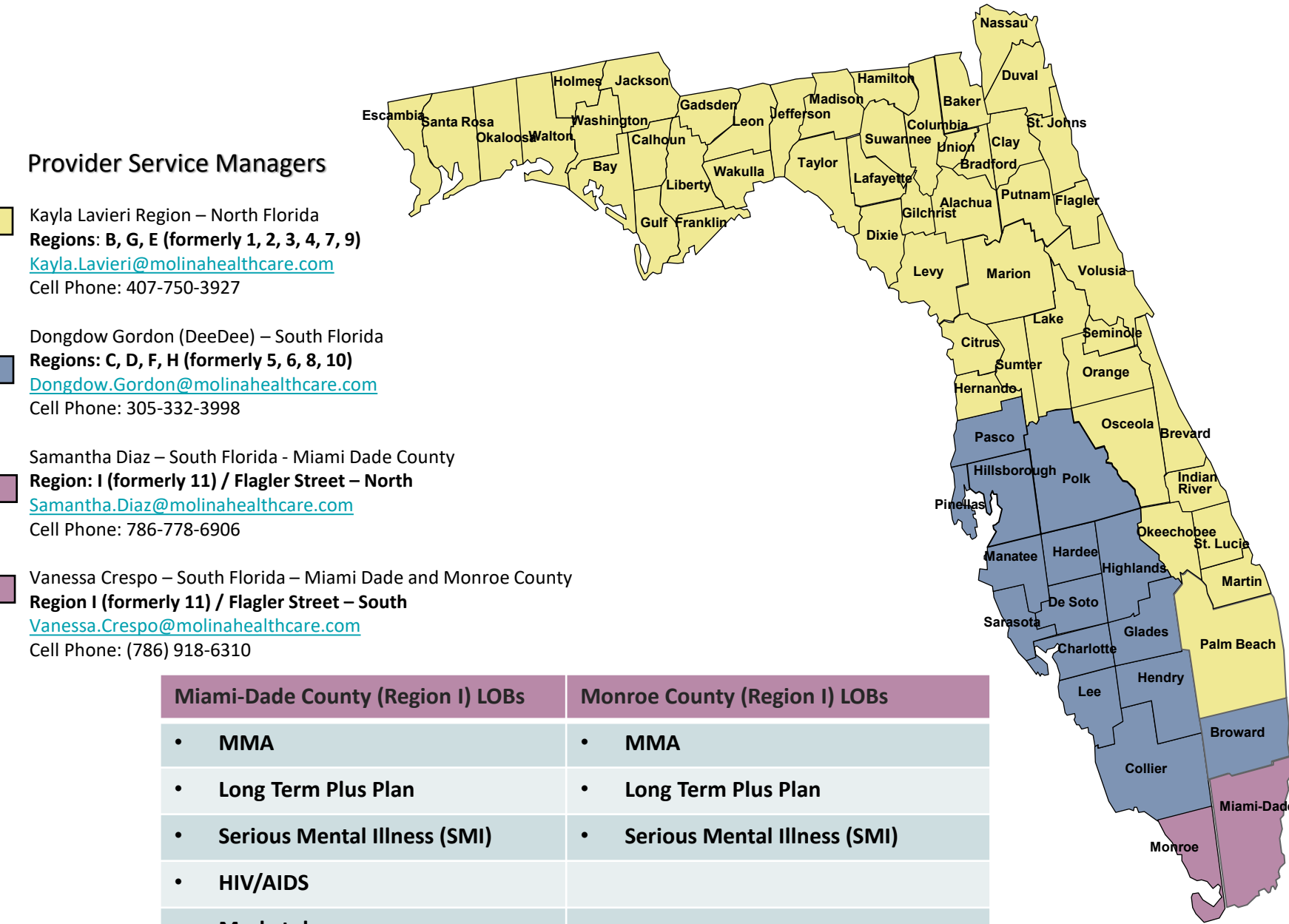
