NOTIFICATION: ANNOUNCEMENT OF CHANGES AND TRAINING OPTIONS

Attention Providers,

This notification is to announce an important upcoming change for Providers required to use Electronic Visit Verification (EVV) for Home Health Services (HHS) being billed on an institutional claim (837i) which is set to be implemented **October 1, 2024**.

At the direction of Iowa Medicaid, and in collaboration with Iowa Total Care, Molina Healthcare of Iowa, and Wellpoint Iowa, CareBridge is making enhancements to the claiming process for all providers, regardless of EVV vendor.

Changes to Home Health Services 837i Claim Elements

To achieve our objectives and respond to feedback from providers, Iowa Medicaid, Iowa Total Care, Molina Healthcare of Iowa, and Wellpoint Iowa have aligned with CareBridge on changes that will allow providers the flexibility to set static or dynamic values for the following data fields, which were previously pre-populated or not included on claims bill through CareBridge:

- Attending Provider
- Referring Provider
- Facility Type Code
- Claim Frequency Code for Initial Claims
- Patient Status Code
- Admission Date/Patient Certification
- Condition Codes
- Value Code

Communication and Training Channels

To ensure providers are well-prepared for these updates, Iowa Medicaid, Iowa Total Care, Molina Healthcare of Iowa, Wellpoint Iowa, and CareBridge will use various communication and training channels. Additional details are included below.
