

FQHC and RHC Coverage Changes Correction

Information for Medicaid providers

Effective July 1, 2022, the Ohio Department of Medicaid (ODM) will implement rule changes to [OAC 5160-28 Federally Qualified Health Center \(FQHC\) and Rural Health Clinic \(RHC\) Services](#). Please reference the OAC rule for details. In the June Provider Bulletin, Molina incorrectly stated ODM would no longer be dually enrolling FQHCs as Community Mental Health Centers (CMHC). ODM will still dually enroll these entities.

Q3 PA Code List Update

Information for all network providers

On June 2, 2022, the updated Prior Authorization (PA) Code List will be posted on our Provider Website for a July 1, 2022, effective date.

To view the list of changes to the PA codes requiring PA, visit the Provider Website, under the "Forms" tab, under "Prior Authorization Code List," and reference the "2022 Q3 PA Code Changes 7-1-2022" tab in the "[Prior Authorization \(PA\) Code List – Effective 7/1/2022](#)" PA Code List. This tab indicates non-covered codes, new codes that require PA, and which codes no longer require PA for all lines of business. This tab also includes a new column that notes the code revision dates for ease of reference. All codes that continue to require PA appear on the "PA Code List" tab and are to be submitted to Molina for review.

Molina posts new comprehensive PA Code Lists to our Provider Website quarterly. However, changes can be made to the lists between comprehensive quarterly updates. Always use the lists posted to our website under the Forms tab instead of printing hard copies. This practice ensures you utilize the most up-to-date versions of Molina's PA requirements.
