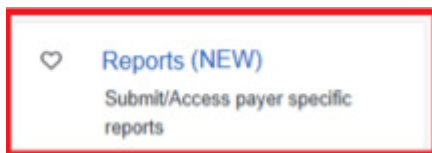
We're excited to announce that the **Reports Tile** currently located in **Payer Spaces** will soon be replaced by the **Reports (New) Tile**.
